#### Question 1

After identifying a file and score to improve in the course accessibility report, is there a way to identify where that file is located (attached) in the course?

(Context: I'm in Blackboard Learn Original. A PDF is reported as untagged and with no language set in the feedback panel, but it says "failed to generate preview" in the preview panel, and there isn't an option to download the file for future upload. We cannot locate this file in the course folders or the course content collection.)

Answer: There may be a few things going on at once here. If the preview is not generated, we recommend creating a support ticket to investigate that as a potential bug.

For tracking file locations, we are looking to do more research towards how we can retrieve a file's location. You can track the idea <u>Ally-I-90</u> in the Idea Exchange.

#### Question 2

Does Ally have a way of distinguishing unused or duplicate Canvas files that might bring down the Accessibility score?

Answer: We do not currently have a way to distinguish these within the Ally reports (or the Course Accessibility Report).

#### Question 3

When adding HTML content in a newly created document within Blackboard Ultra (using the 'add HTML' function), Ally's Alternative Formats (using Immersive Reader for example) display the long form URL instead of the content itself. Are there any plans to improve this?

Answer: Add HTML is serving up the content from a different domain resulting in Ally seeing this as a "link" instead of the HTML content. We will be doing some additional investigation into this specific content use case to determine if we are able to handle this content in a different way.

Question: We are updating our website for students. I want to give more exposure to tools such as Ally that enhance learning. What language do schools use as headers for such webpages?

(I don't want to refer to it simply as "accessibility", but "tools for success" also seems too broad.)

# Password Protected Office and LibreOffice Docs Ally for LMS

- Ally historically flagged and scored password- protected PDF documents with a 0% score.
- We recently expanded this check to include password-protected Microsoft and Libre Office documents and now flag and score those files with a 0% score.

\*This was a go-forward change affecting the score ONLY for new content (since the moment of the release).




